Re: Village of Westport Grant Application to Rehabilitate its Waste Water
Treatment Facility

The Big Rideau Lake Association is dedicated to monitoring and advocating for the sound planning and management of the resources affecting the Big Rideau Lake watershed.

The purpose of this letter is to express grave concern about the Ministry's denial of the Village of Westport's application to the Ontario Community Infrastructure Fund for the remediation of its wastewater plant. Further, we request that that decision be reassessed with the goal that it be reversed.

Westport's water treatment issues immediately effect the waters of Big Rideau Lake, just as they do Upper Rideau Lake, because that lake drains directly east into Big Rideau through the Narrows Causeway lock and dam. Prevailing westerly winds contribute to this flow.

Because of this direct link of Westport's water issues to our shorelines and water quality, we ask that your Ministry direct a portion **our** provincial tax dollars to the resolution of this issue.

We would also remind the Minister and those involved in this decision that Westport and Upper Rideau Lake sit at the headwater of the Rideau Canal World Heritage Site, a UNESCO designation which attracts visitors from around the world every year. It would be shameful for visitors to find degraded water flowing through this once pristine system as a result of a lack of public infrastructure funding.

We respectfully request that the Ministry revisit and reverse the above noted decision to prevent further degradation of Big Rideau Lake's fragile aquatic environment.
