- **There is no electricity or drinking water on Cow Island. Campers must bring their own drinks and snacks as well as adequate amounts of water, a hat and sunscreen.** Campers will be able to purchase tuck shop items daily (chips, candy and pop) on the island. Each item is \$1.00 and campers are allowed a max. of 2 items/day. Tuck must be paid in advance - no tabs.
- This water-access only camp is run by teen counsellors. Parents/guardians are responsible for arranging transportation to and from the island. Children will be supervised when swimming and while on Cow Island, but the BRLA can take no responsibility for injury however caused.
- The volunteer day camp coordinator (adult) will provide support to counsellors but will not be present everyday on Cow Island. Arrangements can be made to meet with camp coordinator during the week.
